



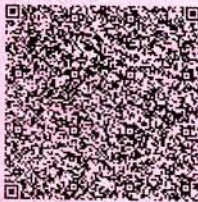

MEMORANDUM OF UNDERSTANDING (MOU):

This Memorandum of Understanding is entered into on this **05/02/2026**.

BETWEEN:

MOVATE TECHNOLOGIES PRIVATE LIMITED, a company incorporated under the laws of India, having its registered office at **6th Floor, Ambit IT Park, No. 32A & B, Ambit Road, Ambattur Industrial Estate, Chennai, Tamil Nadu, India, 600058**, hereinafter referred to as the "**First Party**";

AND

PAGECREATIONZ GLOBAL SERVICES PRIVATE LIMITED, a company incorporated under the laws of India, having its principal place of business at **S102, Door No 769, Spencer Plaza, Anna Salai, Chennai, Tamil Nadu, India - 600002**, hereinafter referred to as the "**Second Party**".

1. PURPOSE

The First Party wishes to engage the Second Party as a preferred vendor for the supply of high-quality, enterprise-grade **refurbished laptops** to meet its internal operational and project-based requirements.

2. SCOPE OF SUPPLY

The Second Party agrees to supply refurbished laptops that adhere to the following standards:

- **Grade Standards:** All units supplied shall be "Grade A" refurbished with minimal cosmetic wear, no structural damage.
- **Battery Performance:** Each unit must hold a minimum battery backup of 2 to 3 hours under standard load.
- **Component Testing:** Comprehensive testing of Wi-Fi, Webcam, Keyboard, Ports, and Storage health must be completed prior to dispatch.
- **Operating System:** Units shall be delivered with a clean installation of the OS -Win 11 pro -TPM specified by the First Party.

3. RESPONSIBILITIES OF THE SECOND PARTY

- **Inventory Management:** Maintain or source the required models as per the First Party's forecasts.
- **Logistics:** Securely package and deliver the hardware to the Ambit IT Park and other facilities within Tamil Nadu.

- **Quality Report:** Provide a basic diagnostic report for each serial number delivered.

4. WARRANTY & AFTER-SALES SERVICE

- **Warranty Period:** The Second Party shall provide a comprehensive warranty of **6 months** from the date of delivery.
- **Repair/Replacement:** In case of hardware failure, the Second Party agrees to repair or replace the unit within **48 hours** of the complaint being raised.

5. PRICING AND BILLING

- **Price Stability:** Prices agreed upon in the quotation shall remain valid for a period of 15 days
- **Payment Terms:** Payment will be released within **15 days** after delivery and successful QC (Quality Check) by the First Party's IT team.
- **Taxes:** Statutory GST shall be applicable as per the prevailing rates in Tamil Nadu.

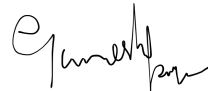
6. CONFIDENTIALITY & NON-DISCLOSURE
